This permit authorized open burning at the above site. This permit is only valid if the following conditions are met:

1. No fire shall be closer than fifty (50) feet from occupied buildings.
2. No fire shall be closer than fifty (50) feet from a public road.
3. Open burning must be attended at all times.
4. Burn will only be conducted when prevailing winds direct the smoke away from the public highway or road.
5. Extinguishing equipment approved by the Ocean Ridge Police Department must be on site, available and ready for use.
6. An Ocean Ridge Police Department must approve the burn site.
7. A hold harmless letter must be provided to the Ocean Ridge Police Dept.
8. The property owner is required to contact the following agencies to report their intent to burn once this permit is signed: Palm Beach County Health Department 561-840-4500, Florida Division of Forestry 850-488-4274.
9. The responsible individual must be at least 21 years old.
10. Applicant must be the property owner or have written permission from the property owner.
- 11. A permit will not be issued if Palm Beach County has a "no burn order" in effect.**

This permit may be withdrawn if any conditions to burn are not met. Ocean Ridge maintains the authority to cease any burn at any time.
