

ORDINANCE NO. 631

AN ORDINANCE OF THE TOWN OF OCEAN RIDGE, FLORIDA, AMENDING ITS CODE OF ORDINANCES BY AMENDING CHAPTER 54 “TRAFFIC AND VEHICLES”, ARTICLE III “PARKING”, BY ENACTING SECTION 54-92 “LOW SPEED VEHICLE PARKING” TO PROVIDE REGULATIONS REGARDING LOW SPEED VEHICLES; PROVIDING FOR CODIFICATION, REPEAL OF CONFLICTING ORDINANCES, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the Town of Ocean Ridge, Florida (the “Town”) is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the Town Commission wishes to provide parking regulations regarding low speed vehicles; and

WHEREAS, the Town Commission has determined that the enactment of this ordinance is for a proper municipal purpose and in the best interests of the residents of the Town.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF OCEAN RIDGE, FLORIDA, AS FOLLOWS:

Section 1. The foregoing Whereas clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof.

Section 2. The Town Commission hereby amends Chapter 54 “Traffic and Vehicles”, Article III “Parking”, of the Town Code of Ordinances to read as follows (additional language underlined and deleted language ~~stricken through~~):

Sec. 54-92. – Low speed vehicle parking.

Low speed vehicles, as defined by Florida Statutes, may park in those spaces specifically designated by signage as approved by the Town Manager or Traffic Engineer. Low speed vehicles shall only be allowed to use those low speed vehicle spaces once a permit from the Town has been obtained. There shall be a resident permit and a non-resident permit. The permit fees shall be set by resolution of the Town Commission.

Section 3 – Codification: The ordinance shall be codified in the Code of Ordinances of the Town of Ocean Ridge, Florida.

Section 4 - Repeal of Conflicting Ordinances: All Ordinances, Resolutions or parts of Ordinances and Resolutions in conflict herewith are hereby repealed.

Section 5 - Severability: If any word, clause, sentence, paragraph, section or part thereof contained in this Ordinance is declared to be unconstitutional, unenforceable, void or inoperative by a court of competent jurisdiction, such declaration shall not affect the validity of the remainder of this Ordinance.

Section 6 - Effective Date: This Ordinance shall become effective immediately upon adoption.
